- I have been informed of any variances with the OYC Bylaws and Moorage Rules that may apply to the floating home I am buying, and I understand what, if any, remediation will be necessary to bring the home into compliance;
- I understand that maintenance dredging is required from time to time to prevent grounding of OYC structures, and that it is the responsibility of all OYC members to share equally in the project costs and cooperate fully in the scheduling, preparation for, and operations of the dredge project;
- I have been informed of, and agree to pay, any current charges associated with my purchase and ownership of my OYC home, and any future charges approved by the Board of Directors and shareholders;
- I hereby certify that all information submitted with this application, including the Personal Information Form, is true, correct and complete;
- I further agree that disputes between OYC and the undersigned may be resolved in Multnomah County Circuit Court and the prevailing party therein shall be awarded court costs and attorney fees, within the limitations of the Release, Indemnification and Assumption of Risk form accompanying this Application.
